

NOTICE OF PUBLIC HEARING

TOWN OF NEW WINDSOR

PLEASE TAKE NOTICE that the Town Board of the Town of New Windsor will hold a public hearing on the 2nd day of March, 2022 at 7:00 p.m. in Town Hall, 555 Union Avenue, New Windsor, New York, for the purpose of hearing public comments on the Town of New Windsor's community development needs, and to discuss the possible submission of a Community Development Block Grant (CDBG) CARES (CV) application for program year 2020 CDBG-CV funding.

New York State Homes and Community Renewal (HCR) is administering over \$127 Million in CDBGCV funding and will make funds available to eligible local governments for housing, economic development, public facilities, public infrastructure, and planning activities, with the principal purpose of benefitting low/moderate income persons.

Town of New Windsor is applying for \$495,600.00 of CDBG-CV funds for the replacement/improvement of the heating, ventilation and air conditioning system (HVAC) as well as installation of new touchless plumbing fixtures and a sensor-activated front entrance door at the Town of New Windsor's senior center, commonly known as the Marasco Center. The hearing will provide further information about the CDBG-CV program and will allow for citizen participation in the development of the proposed grant application and/or to provide technical assistance to develop alternate proposals.

Comments on the CDBG-CV program or proposed project(s) will be received at this time. The hearing is being conducted pursuant to Section 570.486, Subpart I of the CFR and in compliance with the requirements of the Housing and Community Development Act of 1974, as amended.

The location of the hearing is accessible to persons with disabilities. If, due to continued public health and safety concerns related to COVID-19, the Governor of the State of New York extends the State of Emergency, the hearing may be conducted remotely. In the event, the public hearing is conducted remotely, the public will be able to view and participate via the internet and/or telephone.
