

**NOTICE OF SPECIAL ELECTION
SALISBURY MILLS FIRE DISTRICT
FEBRUARY 20, 2024**

NOTICE IS HEREBY GIVEN that a Special Election of the Salisbury Mills Fire District will take place on Tuesday, February 20, 2024 between the hours of 6:00 P.M. and 9:00 P.M. at the Salisbury Mills Firehouse located at 2128 Route 94, Salisbury Mills, New York, for the purpose of voting on the following proposition:

Shall the Resolution entitled:

“RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS OF THE SALISBURY MILLS FIRE DISTRICT (“FIRE DISTRICT”) OF THE TOWNS OF CORNWALL, NEW WINDSOR AND BLOOMING GROVE, COUNTY OF ORANGE, STATE OF NEW YORK, SAID BOARD RESOLUTION ADOPTED ON JANUARY 4, 2024: AUTHORIZING THE FIRE DISTRICT, PURSUANT TO AUTHORITY UNDER SECTION 109-b OF THE GENERAL MUNICIPAL LAW, TO ENTER INTO AN INSTALLMENT PURCHASE CONTRACT TO FINANCE, THE SUM OF FOUR HUNDRED SEVENTY-FIVE THOUSAND AND 00/100 (\$475,000.00) DOLLARS, SAID AMOUNT TO BE DUE, UPON DELIVERY AND ACCEPTANCE, ON THE PURCHASE AND UPGRADE OF SELF-CONTAINED BREATHING APPARATUS, TOGETHER WITH NECESSARY EQUIPMENT RELATED THERETO, WITH A TOTAL MAXIMUM COST OF FOUR HUNDRED SEVENTY-FIVE THOUSAND AND 00/100 (\$475,000.00) DOLLARS; STATING THAT THE FORM, TERMS AND CONTENT OF SAID INSTALLMENT PURCHASE CONTRACT SHALL SUBSTANTIALLY CONFORM TO THE REQUIREMENTS OF SECTION 109-b OF THE GENERAL MUNICIPAL LAW AND OTHER APPLICABLE STATUTES; AND APPROPRIATING SAID AMOUNTS THEREFOR TO PAY THE PRINCIPAL AND INTEREST WHEN DUE,” BE APPROVED?

All residents of the Salisbury Mills Fire District, who are duly registered to vote with the Orange County Board of Elections on or before January 29, 2024 shall be entitled to vote at this election.
